2 PAYMENT TERMS

All bookings involving costs must be settled by credit card (**VISA, Mastercard or American Express**) or by **bank transfer/payment slip (for residents from Switzerland)**. Please note, that all fees have to be settled prior to the event. Delayed payments will be subject to a surcharge of CHF 30.-.

3 AMENDMENTS AND CANCELLATIONS

4 CANCELLATION FEES

From 1st February 2016: CHF 50.-

From 1st July 2016: 100% of the booking total

Name changes are accepted before the booking has been cancelled and will be charged with a handling fee of CHF 25.-. Bank fees in case of return debit notes are at the participant's expense. An invoice by post will only be sent out if required by the participant and will be charged with CHF 10.-.

5 OTHER CONDITIONS
